We believe that the audit evidence we have obtained is sufficient and appropriate to provide a reasonable basis for our audit opinion.

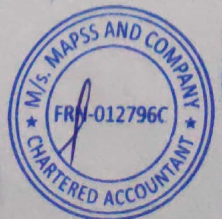
4. Opinion :

6. Observation & Suggestion (Cash Payments)

Observation:

During the audit, it was observed that cash payments have been made frequently, including for high-value transactions. Under Section 40A(3) of the Income-tax Act, 1961, any business/professional expenditure paid in cash exceeding ₹10,000 to a person in a day (₹35,000 for payments to goods-carriage operators) is liable to 100% disallowance in computing taxable income, subject to limited exceptions under Rule 6DD.

Further, for government offices and public institutions, the General Financial Rules (GFR), 2017 emphasize financial propriety, transparency, and use of banking/electronic modes for payments; cash disbursements are intended only for petty/minor expenses and within delegated financial powers, not for large payments.

Suggestion:

The concerned authority should:

Mandate account-payee cheque/NEFT/RTGS/UPI for all payments above the threshold; allow cash only for genuine petty expenses with proper vouchers and approval.

Require vendors/suppliers to provide bank details and insist on electronic settlement; maintain a cash-payment register with justification where cash is unavoidable.
